

# Covid-19 Special Rates for Streaming

For new recordings

Whilst restrictions continue to limit live ensemble performances, the MU continues to receive a substantial number of rate enquiries for streaming live ensemble concerts online. With no audience or very limited audiences allowed, ensembles and producers have been working to find ways in which they can broadcast their performances online.

This often goes beyond the one live transmission put in place of a standard concert in normal times, with a request for the recording to be kept online for a period after or transmitted again. With the current rates in place, the only option would be to clear for online rights in perpetuity which is often not required or affordable and means that the work cannot go ahead.

We are understanding of the current need for alternatives when wishing to keep the concert online for a short period, or requiring further transmissions rather than perpetual rights. As a special measure, we are making a number of fees available during this period, to ensure streaming can go ahead with relative ease, and to ensure musicians are fairly remunerated.

These fees are in addition to the musicians' live performance fee which should be in line with MU rates, and are only available for *live* ensemble performances of up to 2 hours. The rates only apply to in-house productions and where audiences are limited due to the current restrictions. Where streaming is managed by an outside promoter or a full live audience is allowed, payment of the necessary <u>PACT/MU Rates</u> would be required.

Without prior notice on the MU website, these rates will cease on 1 January 2022.

- The above rates are available for a limited period whilst the Coronavirus pandemic continues. The MU will place notice on its website when these rates will cease. Otherwise, they will cease to be available after 1 January 2022.
- The attached consent form must be completed and returned to the Musicians' Union (session.agreements@themu.org).
- Full PACT/MU rates apply for any of the following:
  - o streaming is required for longer than 6 months.
  - steaming is managed by an outside promoter / it is not an in-house production.



- o a full live audience is in attendance
- Live performance fees including any overtime, doubling, porterage to be agreed separately and must be in line with MU rates.
- Maximum concert length, 2 hours.
