

# Covid-19 Special Rates for Streaming

For existing recordings

Whilst restrictions continue to limit live ensemble performances, the MU is receiving a substantial number of requests to clear musicians for further use of existing recorded material. Both ensembles, producers and promoters naturally wish to retain a keen hold on their audiences. We agree promoting ensembles at this time is a worthwhile and positive thing to do.

However, our members, most of whom are freelance players, and especially when income is short, should not be the ones who lose out on further exploitation of rights which they hold in those performances.

As a special measure, we are making available a number of fees during this period, to ensure streaming can go ahead with relative ease, and to ensure musicians are rightly remunerated. Without prior notice on the MU website, these rates will cease on 1 January 2022.

In addition, for fees for rights, it goes without saying that the fees are in addition to any new recordings being made for purposes of streaming, whether in studio or from home recording base.

#### Rates

One-off or limit to 24 hours period streaming (no further ability to view)	£50 per musician
Up to 30 days streaming	£60 per musician
Up to 3 months streaming	£75 per musician
Up to 3 months streaming	£100 per musician

- The above rates are available for a limited period whilst the Coronavirus pandemic continues. The MU will place notice on its website when these rates will cease. Otherwise, they will cease to be available after 1 January 2022.
- The attached proforma must be completed and returned to the Musicians' Union (licensing@themu.org).
- Notification of the line-up of players is a compulsory requirement.
